Our work comprises M&A transactions, greenfield project development, financing, regulatory matters, representation of clients in administrative and judicial discussions and general legal assistance involving the sector. A major highlight of our experience is in the field of renewable energy, especially wind power, solar power, biomass, and biomethane.

Our professionals also assist in the development of projects with several Brazilian public authorities at all federal levels, from project modeling, advising on bidding processes, structuring of privatization processes of state-owned companies and infrastructure, as well as modeling and managing common concession and public-private partnership agreements. In addition, we have significant experience interfacing on a range of matters with regulatory agencies and oversight bodies such as the Auditors' Courts at federal and state level.

The parties also entered into a development agreement for future business opportunities in the power transmission sector.
