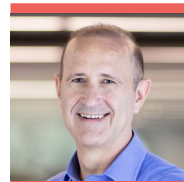
EXPERIENCE

- Extensive experience in trade defense investigations defending exporters, importers, and interested third parties, as well as assisting domestic industry in their claims. Our experience involves more than 30 antidumping investigations in Brazil, including national cases of great relevance, such as aluminum rolled products (China); plastic tubes for vacuum blood collection (China, Germany, USA, and the UK); cargo tires (South Korea, Taiwan, Thailand, South Africa, Russia, and Japan) (China); ferrite magnets (China and Korea) magnets (China and Korea); flat steel bars (China); elastomeric rubber tubes (Germany, Korea, United Arab Emirates, Italy, and Malaysia); polymeric MDI (Belgium, Hungary, Portugal, the Netherlands, Germany, South Korea, and Spain); flat-rolled products (Australia, China, India, Mexico, and South Korea); and others.
- In addition to our national work, we advised Brazilian exporters in anti-dumping investigations against Brazil, such as in the cases of the United States, of PET, concluded without the imposition of antidumping duties (2017-2018) and Argentina, for ceramic sanitary ware (review, 2015-2016);

- Among other experiences.

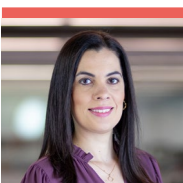
