## EXPERIENCE

**NEOENERGIA:** Sale, by Neoenergia to the GIC group, of 50% equity interest in Neoenergia Transmissora 15 SPE S.A. (with 8 operating transmission assets), which should work as an investment platform between Neoenergia and the GIC group. The parties also entered into a development agreement for future business opportunities in the power transmission sector.

**RED ELÉCTRICA (REDEIA), GRUPO ENERGÍA DE BOGOTÁ, and ARGO ENERGIA:** Advising on the acquisition, by Grupo Energía de Bogotá and Argo Energía (owned by Grupo Redeia and Grupo Energía de Bogotá), of 100% controlling interest in 5 energy transmission concessionaires owned by Quantum/Brookfield Group.
